

**Dining Pavilion Opening
Woodfield Mall
Facebook Fan Promotion**

Official Rules and Regulations

ENTRY: This promotion begins on Thursday, May 31, 2018 at 7:00 a.m. CST and ends on Wednesday, July 11, 2018 at 11:59:59 p.m. CST (“Promotion Period”).
